

On Tuesday 4.12.90 Mrs LINBURN/Carole, 82 Moa Rd, Pt Chevalier, and her son Anthony called at my office. Also present was Volunteer [REDACTED]

Mrs LINBURN, as usual, was complaining about the foul mouths and deeds of her neighbours. She wanted to know what I was going to do about it.

I know LINBURN well. She is the only person I have met in my entire Police career that leaves me with a feeling of total despair every time we meet or speak.

I have visited LINBURN on 16.5.90, 18.5.90, and 8.8.90. As well, I have spoken to her by phone on numerous occasions. She is always complaining about neighbours, shopkeepers, the Police, Social Welfare and anyone else she can think of.

One time I visited her address with Constable PALMER but her response is always the same; she will talk at you but will never listen. In short, she expects the Police to arrest and take away and punish the people she complains over. Her complaints are usually unfounded as we find that she is the perpetrator of most incidents and the other people are usually only retaliating.

LINBURN has been diagnosed as a paranoid schizophrenic (I have contacted her doctor) and her life appears to go in cycles but is usually in some turmoil.

LINBURN is well known to local members, members at Control and Avondale. I do not know what can be done to stop her wasting our time and cannot help feeling that one day she is going to do something 'outrageous' and innocent people may well be victims. Her son Anthony does not appear very more rational than she.

I submit this file for DocLoc and your informaton. Perhaps Records Office staff can obtain all previous files on LINBURN and build a dossier, a copy of which could be kept at my office?

As you are aware I have had recent discussions with Mr [REDACTED] of Housing Corporation, phone 815-3210, in relation to Mrs LYMBURN's continued tenancy of the premises at 81 Moa Road, Westmere.

Mr [REDACTED] informs me that the Housing Corporation are investigating the possibility of terminating the tenancy, but indicates that this is not likely to occur inside the next four months given the requirement for them to provide the tenant with ninety days notice.

I have also discussed the situation with [REDACTED] and given her some verbal guidelines for dealing with Mrs LYMBURN. This memorandum is formal confirmation of the guidelines which I wish to be followed at your office in those dealings.

1. On any occasion Mrs LYMBURN calls at the Westmere/Pt Chevalier Community Constables office wishing to make a complaint of any type, she is to be informed that she should make her complaint directly to the Senior Sergeant at Ponsonby Police Station.
2. Mrs LYMBURN should then be asked to leave the premises.
3. Should she fail to leave the premises on request of a volunteer, that volunteer should call the Ponsonby Police Station and request assistance in having Mrs LYMBURN removed.

Please ensure that the contents of this memorandum are brought to the attention of all your volunteers and attached the memorandum to your office file relating to Mrs LYMBURN.

On 8.4.91 I spoke with Phil BEILBY, Charge Nurse at Ponsonby Care Centre..

He has had discussions with Mrs LYMBURN since December 1990. Mrs LYMBURN has been reluctant to accept help.

Mr BEILBY offered her the opportunity for support to deal with the distress she is suffering (apparently due to a problem she has with neighbours).

On 20 March 1991 Mrs LYMBURN phoned Mr BEILBY demanding to know what he had done about her complaints. She accused the Care Centre for being responsible for releasing psychiatric patients into her neighbourhood. Mr BEILBY offered her support again but became agitated and accused him of casting innuendos about her.

Mr BEILBY has spoken with Barbara MORRIS, LYMBURN's own doctor. Dr MORRIS considers Mrs LYMBURN to be very eccentric but not a committable person nor dangerous. Mr BEILBY assesses her to be neurotic and probably schizophrenic.

Any Police response to Mrs LYMBURN's letter will only give her more opportunity to select, exaggerate, twist and distort what is said. She will only become more upset.

I therefore suggest that no response be made and the letter attached be filed.

Constable Brent MATHIESON may wish to note the contents of the letter first.

Dear Mr EDMOND,

I have been forced to write to you, because I can't get a satisfactory or honest response from one of the Employees who is with Mental Health Services, Care Team Auckland.

I spoke to a young woman Mrs Sue FARRELL from your sector, to whom I expressed my concerns, and she was extremely helpful and understood the seriousness of what has taken place. She explained that I would have confirmation of my verbal complaint in a few days and that it was to be put to a Senior Manager for decision.

I am deeply concerned that all the information is not in your hands as it is very complex and I want you to have all of the information to be able to grasp the full concept of what is going on.

MY CONCERNS ARE AS FOLLOWS:

I spoke to Dr Christine PERKINS on Tuesday 10th December 1996, about a report which she had hand written in 1994, during a conversation on the telephone with a Manager from Housing New Zealand about myself and my mother Carole LYMBURN who resides at 82 Moa Road Pt Chevalier.

All the information taken down on her record was totally untrue extremely damaging to our reputations and very clearly defamatory.

After legal address through the Tenancy Tribunal at which my mother filed that Housing New Zealand were allowing several of their tenants to harrass and threaten her and on two occasions had assaulted me, we applied for records from Housing New Zealand and The Waitakere Unit under the Privacy Act .

We were shocked at what we found on file.

We discovered that Housing New Zealand tenants had told lies about my mother and that they had taken up a petition to have her removed from her unit and the Police were going to help Housing New Zealand to evict my mother.

The people who were signing the petition got all their friends to sign it and we have since discovered that one of the signatures that of Maire LEADBEATER was forged or at least this is what she has declared in writing to me.
Other signatories have committed the most disgusting behaviour towards us and are associated with the most dreadful drug criminals.

Worst of all, they have conspired to have my mother and I declared some sort of mental degenerates, and destroy us for telling the truth when we have not done one thing wrong only try to set an example and live decently and in peace.

I faxed Miss PERKINS with her own reports, in her own handwriting, and she is refusing to accept ownership of these reports, and is deliberately avoiding my calls and communications. She said to me on the phone that "Mr Ogle from Housing New Zealand was trying to help."

My reply to that was that to try and have you evicted from your home, behind your back was not exactly helping, and she hung the phone up on me.

I resent having to pay my solicitor to write to her to remind her of her Professional obligations, so I call on you to direct her answer to me.

TO IDENTIFY THE FOLLOWING:

1. Whether the report which includes the following statements are her words, or are they that of Mr Graeme OGLE from Housing New Zealand.

"She is unable to live at peace locals"

"Strong racist views she calls people Black Bastards"

"Constantly making complaints to Police Re; Harrassment and persecution"

"Police have visited her frequently yelling at passersby- Slams doors."

"Son seems to be very much the same as her" ETC ETC ETC as her report shows

2. Explain to me why she rang Dr Wernham G.P. at the Pt Chevalier Medical Practice and what was she enquiring about?

3 On the 28th November 1994 when aDr Perkins spoke to Constable Yvonne CARLTON 3786455 (Police) she has written in her notes:

"Had a fight, son also involved and going to fight again.....

Police called in.....but not a danger to self? others

Police Constable concerned but accepts she is not currently committable".

EXPLAIN TO ME WHAT IS GOING ON HERE?

The man who threatened our lives was in fact a violent drug criminal called CHATTERTON who was an associate of the woman whom I wrote to Helen WARREN about and who said she could not do anything to help us. I enclose copies of CHATTERTON'S convictions for you to see what we have been up against and why Housing New Zealand and the Police want to coverup the truth.

I appeal to you to ask Miss Perkins to explain her position, instead of being an accomplice with Housing New Zealand to defame us....., when we are the innocent parties and so called Professionals are trying to avoid a disgusting situation and make out we are both to blame, by saying there is something mentally wrong with us.

I can assure you Mr Edmond, that we will fight to the bitter end to restore our good names and reputations and discredit the ones who have degraded us, taken away our self respect and self esteem. You can not imagine how we feel, to have been tormented for so long and the to find that the people who are in positions to help us, have betrayed us.

I appreciate your assistance in this matter and that of Mrs Farrell.

Dear Miss Warren,

I spoke to you about two weeks ago regarding a woman on your drug programme.

In 31st May 1992 I saw a woman leaving your clinic in the company of two children and two dogs.

I recognised her to be the woman who on 5th November 1991, in the company of three other people, assaulted me on the street outside my mothers house, pulling my hair, punching my face, and bashing me down on the concrete, injuring my right arm. I had to have medical treatment and physiotherapy for the damage to my elbow. She took my glasses valued at \$250 and would not return them.

In 6th November 1991 she returned to my mothers house in the company of Gary Chatterton, a drug criminal. My mother was alone and he threatened her and was going to kill us. He said to my mother, "You slut, you prostitute, you whore," and "Last night five men came around here and raped you." He was crazed and smashed all ~~her~~ potted plants. The woman held my glasses up to my mother

at her window and said "Come out and get them or I'll Smash-them."

My ~~my~~ mother was afraid to go out to get my glasses. So the woman Smashed them at the front gate. My mother found a piece of the lens and my optician tested it. He confirms it was from my glasses.

I believe I have now identified this woman to be Aner Lorraine BROWN and she has spent many months tormenting and terrorising my mother.

On 30th October 1991 she approached my mother on the street and blocked her way. She criticised her, abused her, and threatened her. She then spat over my mothers clothes saying "I hope you catch aids" and "I wish you would die, you fucking old bitch." She used filth and abuse at my mother all the way down the street to my mothers gate.

I bring it to your attention that this woman is dangerous and very violent and my mother had to make two complaints to the Police about her child using filth and obscene talk to her at her front gate. (Complaints made to Constable Grant on 8/6/92 and Sgt Mitchell on 10/6/92, both at the Central Police Station)

you inferred you would, with the assistance of other areas e.g. Social Welfare, deal with this

matter.

Please advise me what you have done to control your patient and ensure my future safety and especially the safety of my elderly mother who is now an innocent victim.

Thankyou for your letters of June 22 and 14 July. I apologise for my tardiness in replying.

Whilst I can appreciate the dilemma you and your mother are in, I am only able to respond to your letter in a very general way.

The Auckland Drug Dependency Clinic is an outpatient treatment service of the Auckland Area Health Board, and as such, patients must be able to receive treatment here without fear of their circumstances being disclosed to others. For this reason, I am not even able to confirm to you whether or not the woman you complain of is on our programme.

However, I am able to advise you in a general way, that all clients on our programme receive regular monitoring and counselling. Naturally, we are not able to control their behaviour outside of the clinic grounds.

Thankyou for bringing this matter to our attention.

Extra 6 months added to two-year term

A Mt Roskill man who was sentenced last week to two years in prison on drugs charges had another six months added to his jail term yesterday.

Gary Russell Chatterton, aged 37, a secondhand furniture dealer, appeared in the Auckland District Court for sentencing on charges of using cocaine, possessing temgesic tablets, possessing cannabis and allowing his house to be used for a drug offence.

He was also sentenced on three assault charges, two counts of failing to answer bail and one charge of possessing an offensive weapon, namely a baseball bat.

Counsel for Chatterton, Mr David McNaughton, asked Judge P. J. Duncan to sentence his client to con-

current jail terms on the charges because he was already serving a two-year prison sentence following convictions for possessing heroin and possessing morphine for supply.

The drugs charges arose after police raided Chatterton's home in the early hours of May 27.

Two plastic bags containing cannabis and 27 temgesic tablets were found in a bedroom.

Three needles and syringes and pieces of paper showing a residue lay on a table in the lounge.

Chatterton said he and two friends had been injecting themselves with cocaine earlier in the night.

Mr McNaughton said Chatterton — who pleaded guilty to all of the charges — had been a drug addict for 15 years.

He had assaulted a man who had intervened during a violent argument with his wife and, on another occasion, two youths who he believed had interfered with his car.

Judge Duncan sentenced Chatterton to prison for 12 months for allowing his home to be used for the drug offences, three months for using cocaine and two months for each charge of possessing temgesic tablets and cannabis.

The sentences were to be served concurrently with the two-year term imposed by the High Court at Auckland last week.

Concurrent jail terms of six months for each of the assault and offensive weapon charges and six weeks for the failing to answer bail charges were ordered by Judge Duncan to be served cumulatively with the two-year sentence.

Heroin accused 30 JUN 1989 HERALD fails to appear

A warrant has been issued for a Sandringham man charged with possessing heroin for supply, who failed to appear in the Auckland District Court yesterday.

Gary Russell Chatterton, a 37-year-old secondhand dealer, was charged with possessing heroin (a Class A drug) for supply on April 27.

He was also jointly charged, with an unemployed Stillwater woman, Diane Elizabeth Sheen, 28, of possessing morphine, a Class B drug, for supply.

Sheen, who did appear before Judge C. J. Rushton, faced an additional charge of selling morphine.

She was remanded on bail for a depositions hearing on August 22.

Drug binge ends in prison

14 OCT 1969
A Mt Roskill man who had been "bingeing" on drugs when police raided his house has been sent to prison for two years.

Gary Russell Chatterton, aged 37, a secondhand furniture dealer, appeared for sentence in the High Court at Auckland yesterday after pleading guilty to charges of possessing heroin, and possessing morphine for supply.

Mr Justice Robertson said that Chatterton's life had been bedevilled by drug abuse, yet he allowed himself to become a link in the network which supplied misery to other addicts.

"I have no doubt that the court must mark society's absolute condemnation of any who feed the habit in others," Mr Justice Robertson said.

"You are probably the classic example of what drugs do to people. For about 12 years drugs have dominated you..."

Chatterton was sentenced to two years' jail on the morphine charge, and a concurrent term of three months for possessing heroin.

The sentence took into account the four months the defendant had already spent in prison on remand.

Mr David McNaughton, defence counsel, submitted that Chatterton had been on a two-week drug "binge" when police searched his home.

Mr McNaughton said that the drug binge followed the breakdown of the defendant's marriage, and came after almost two years on a methadone maintenance programme.

It was while in such a vulnerable state that Chatterton became involved in a scheme to distribute morphine which had been brought to Auckland from Gisborne by a woman friend.

Three needles and syringes and pieces of paper showing a residue lay on a table in the lounge.

The defendant said the tablets were for his own use.

He and two friends had been injecting themselves with cocaine earlier in the night.

Chatterton said he bought the drug from another friend.

He was out on Bail this day

Dear Mr EDMOND,

Thank you for your acknowledgements to my letters and I will instruct my mother to write to you to authorise release of her medical records for the purpose of this investigation.

We have spent some considerable time today discussing various aspects of what is happening and are still concerned that our case has not been totally ~~put~~ put across to you.

I would therefore like you to have further documents to help you to deal with the matter in more depth.

As you will find in my mothers medical records, she has never had any history of mental illness and for anyone to put that 'label' on her or me, to cover up what they have failed to take responsibility for, is to us, a criminal thing to do. They have used their position to condemn another person in the eyes of the rest of society, and that person has not had the power, or the influence to fight back.

I am specifically referring to Housing New Zealand in this case, together with certain members of the Police as well who have used their influence to dishonour my mothers reputation.

They have used the Medical Profession to do this, and this is why we regard it as an extremely serious issue.

Mr Ogle, from Housing New Zealand, rang everyone he could think of, in Medical circles and wrote to everyone who would listen to him, and he has involved quite a number of people.

Our family name LYMBURN is a very unusual name {Scottish} and people remember it. My mother has had reactions from Medical people during her visits to the hospitals who obviously must have seen something to the effect that she is mentally unwell.

I enclose copies of Mr Ogles notes, which show the considerable lengths he went to, to destroy my mother's good name.

I feel that this is outrageous.

These people have put a slurr on our whole family.

My brothers and I feel very angry about this, and want our family name cleared. My grandmother lived to the age of 90 and her mind was totally sound so was my grandfather. No one in our family have ever been treated for a mental illness, an addiction, or anything that can be regarded as anti social or 'not normal' to so speak. We feel we are having to justify who we are all the time, and it is a very distressing situation to be in.

I will not let these people do this to us and get away with it, and this is where you can help us.

We are good people and deserve the repect of good people.

It is very plain to see that Professionals have used my mother's circumstances to do this to her, using her age as a weapon against her, and I just become very alarmed to think who else they do it to as well.

There are a lot of elderly people out there who don't have anyone to look out for their interests and when there are people like Mr Ogle, these people are very vulnerable, particularly if he wants to sell off their State house, he is in the Properties Division of Housing New Zealand and was very keen to have my mother evicted from her unit.

It seems these days if you don't utter filthy language, take drugs, or go around committing violent acts, or damaging property, then you are considered 'mental'. I must say that I get more out of life living by the principles my mother taught me, and the type of people we associate with feel exactly the same, and as I said before we are good people.

Thank you for allowing me to express my views.

I am writing to you at the suggestion of Sally Monks of the Ponsonby Care Centre, about the abovenamed who is renting the Moa Road property from Housing New Zealand.

From the outset of her tenancy in 1980, Mrs Lymburn has been a difficult person for us to deal with. She seems unable to live at peace within the community, seems unable to live with the adjoining tenant (both the current and previous tenants) and seems unable to accept a multi-cultural society. She has often complained that she is being harrassed or persecuted and regularly complains to this office and to the Police. We are aware of considerable ill feeling within the local community towards her and her son.

On each occasion that phone calls are received from Mrs Lymburn by this office, the discussion quickly deteriorates to the point that there is little benefit in continuing. From my own experience, it is simply not possible to carry on a reasoned discussion with her and whatever is said to her is twisted or construed to have another, deeper meaning.

The situation with Mrs Lymburn has now reached the point where we feel compelled to take stronger action. Tenants place their occupancy of rented accommodation in jeopardy if they cause any interference with the reasonable peace, comfort, or privacy of other tenants or of any other person residing in the neighbourhood. An application to the Tenancy tribunal to end Mrs Lymburn's tenancy is being considered, but because of her circumstances we want to involve others in the community to seek alternative solutions. As well as making contact with the Police, we have spoken to Community Health Services and, as stated earlier, the Ponsonby Care Centre.

If you feel that you may be able to assist, we would like to have the opportunity to discuss the situation with you.

We would certainly appreciate your involvement and some formal feedback from you. If this matter should more-appropriately dealt with by some other agency, I would be grateful if you could advise as soon as possible.

MEETING

After outlining the problems, Ann confirmed that her agency was unable to do anything to assist. She said that given Mrs Lymburn's age, she was unlikely to change and suggested that a more appropriate agency would be either:

- a) Waitakere Hospital Psychiatric Services for the Elderly (Alan Baker) - Ph 837-2777 or,
- b) The St Lukes Mental Health Service - Ph 846-4116.

I have so far been unable to get a response from Alan Baker (left a message on his answerphone).

I phoned the St Lukes Mental Health Service who referred me to the Ponsonby Care Centre.* The latter confirmed that they are aware of Mrs Lymburn (although nothing recent) but since all staff were tied up in a meeting, I have asked that the Duty Officer call me back.
