

## INCIDENTS IN POINT CHEVALIER

-1-

I was approached on the street in Pt Chevalier by a woman and called a "lesbian" and a "stuck up bitch" and I reported this incident to the Police.

---

✓ I was chased into the hardware shop in Pt Chev by a woman and threatened that if I didn't "shut my mouth" she would "cut my throat". The shop keeper let me phone the Police who arrived and drove me home in the Police car.

---

I was banned by the Manager at the Woolworths Supermarket and the staff all yelled out in the store publicly that I was of bad character and they did not want me in the store. I had to obtain through my lawyer, a letter from the Woolworths Company Office to say that I was free to visit the store. See attached letters.

---

✓ On February 13<sup>th</sup> 1991, the morning after my sister June had been buried in the United States and I was grieving her loss I received a very threatening phone call to "keep my door locked" that "they were going to get me".

---

✓ On Sunday 8<sup>th</sup> December 1991 I received a phone call from a woman saying she was ringing from the Auckland Hospital and that my son had been involved in an accident. I have three sons and when I asked which one. She hesitated and said the one from Grey Lynn and hung up the phone.

Mrs Kaka, my next door neighbour at number 82 adjoining my flat, had her ex-husband living with her in her flat, for a few months. During this time they both consistently drank in their flat, raised their voices excessively, argued, and kept me awake night after night for many weeks.

The blood vessels in my eyes burst and bled into my eyes through lack of sleep.

Mr Kaka abused me and threatened me with violence because I was complaining about their behaviour.

Eventually they had a major argument and he left.

Mrs Kaka came to my door to tell me to phone the Police if he ever came back. My son was visiting and he told her to leave the property.

---

Mrs Kaka then took up with a man called Tahere who moved in with her for many months.

They too drank till all hours, yelling, banging the walls, screaming out and disturbing my ability to sleep. I complained to Housing Corporation as it was then known as.

Tahere threatened to attack me and one day charged up to the fence screaming at me that he would "hit me over the head with a rock". I consistently reported these events of violence to the Police as I felt I needed protection.

Tahere also threatened my son and so Anthony made a complaint against him. Re letter from Police 11/10/1989

After he was warned officially he took off and never returned.

Tahere was responsible for another downturn in my health.

The fright and shock I sustained from him sent my blood pressure to a very dangerous level and I had to go on to medication for high blood pressure which had adverse side effects.

I had to go on to Blood pressure tablets for life.

---

Mrs Kaka was consistently causing trouble for me by setting people on to me, saying I was a racist. She told me she had a son in a "gang". She said publicly that I was not a decent woman and that I had suffered mental illness by being treated in Carrington.

✓ The whole neighbourhood was yelling these accusations at me all the time. Saying the Police say you are mental.

Mr York who resided at 71 Moa Road across the street kept dogs which ran wild and were never fed.

One of the dogs an Alsatian bitch with a litter of puppies was so undernourished her ribs were protruding.

I refrained from reporting it until she came and started eating bread on my lawn that I had thrown out for the birds. I reported it to the SPCA.

✓ I was told by them that there had been other complaints and if I reported it again the dog would be taken away and destroyed.

I never complained again.

The dog continued to starve.

I was extremely distressed over the cruelty to this poor animal.

One day the dog disappeared.

York and his wife would argue loudly and would yell out obscene language. My windows are high up and faced their property and I could hear the force of their arguing.

York would keep me awake at nights stacking crates of bottles on his SPORT DRINK truck, sometimes to 1am in the morning.

---

Ruby Miller in Kanuka Street had back steps that faced out to the front of my property. For many months I would be going to my letterbox to clear my herald or mail and she would stand on her steps looking over calling out obscene language.

One day I finally was forced to say to her "Be quiet".

---

✓ Alexis Dilmott a neighbour up the street and friend of the other neighbours consistently abused me when I passed her house to go to the shops. She called me filthy names.

I reported her to the Police. She admitted doing this to me.

I had to seek lawyer's advice and my lawyer wrote to her warning her to stop. Refer lawyers letter 3/11/1978. /987

✓ A resident at 71 Moa Road had a dog which I saw him training to be vicious.

He was screaming at it to the point where it was crawling along the ground on it's stomach in abeyance and then he would punch it. Then he would swing a baseball bat at it to make it retaliate.

I opened my window and called out "if you don't stop punching that puppy I will report you to the SPCA".

He replied "You Fucking nosey old bitch".

Then a woman arrived at my door screaming in a frenzy that she was going to get me, pounding on my doors and bedroom windows.

I was forced to call the Police down.

---

✓ The child from 81 Moa Road called Adams began to call out filthy language to me on the street and at my lounge windows which look out to a reserve. "Get Fucked" and "Go fuck yourself".

Everytime I was on the street I was subjected to filth from him and he was obviously out of control.

My son and I approached Constable Mathieson on the 4<sup>th</sup> December 1990 and he refused to take any action saying they were a "nice family".

My son challenged the child that afternoon when he again yelled obscene language at us as we were returning from the supermarket. My son went to his house number 81 Moa Road and knocked on the door to speak to his mother.

A woman came out claiming to be his mother and a man in her company.

My son explained that the boy was annoying me and asked them to put a stop to it.

They both abused and threatened my son and said they would punch him. They called him a "poofter" "Fairy" and to go home and "root his boyfriend" then go and "root your old lady, you both have got aids".

I laid a complaint at the Central Station on 5<sup>th</sup> December 1990.

---

On Sunday 8<sup>th</sup> December 1990 and Monday 9<sup>th</sup> December 1990 I was subjected to obscene abuse by the Adams child again and youths in his company.

On the Sunday I called the Police to them and after the Police left the property the gang continued to abuse me for a further 4 hours.

They did a haka, exposed their buttocks, exposed their rectum's, the child told me to "suck his cock" and they made spectacle so that the whole neighbourhood could see.

✓ Mrs Kaka, my next door neighbour was talking to them the whole time encouraging them to do this to me. She said she was their Aunty. They abused me about my looks, my underwear on my line, and threatened to beat my son up when he arrived.

I reported the Adam's boy to his Headmaster at Pasadena school but he did not want to be involved, he said he had a wife and children to worry about.

This child was obsessed with sex talk and appeared emotionally disturbed as he was squealing and screaming hysterically when there was any mention of his behaviour.

13th May

1986 ✓

✓ A short time after I had moved into Moa Road my cat strayed off the property to that of my neighbour at 84 Moa Road Mr Rogers.

My cat walked on to some wet cement. Mr Rogers kicked my cat out of the way with his work boot.

My son Karl had to rush the cat to the vet where he haemorrhaged from the lungs and died that night.

On another incident when Mr Rogers children were trespassing and Throwing cardboard cartons into my section we went next door to talk to him.

He ordered us off the property and threatened to shoot my son and grazed him across the face as he took a swipe at him.

He referred to me as a "redheaded whore."

Lawyers letters were sent to him. 2/7/86

On Tuesday 4.12.90 Mrs LINBURN/Carole, 82 Moa Rd, Pt Chevalier, and her son Anthony called at my office. Also present was Volunteer [REDACTED]

Mrs LINBURN, as usual, was complaining about the foul mouths and deeds of her neighbours. She wanted to know what I was going to do about it.

I know LINBURN well. She is the only person I have met in my entire Police career that leaves me with a feeling of total despair every time we meet or speak.

I have visited LINBURN on 16.5.90, 18.5.90, and 8.8.90. As well, I have spoken to her by phone on numerous occasions. She is always complaining about neighbours, shopkeepers, the Police, Social Welfare and anyone else she can think of.

One time I visited her address with Constable PALMER but her response is always the same; she will talk at you but will never listen. In short, she expects the Police to arrest and take away and punish the people she complains over. Her complaints are usually unfounded as we find that she is the perpetrator of most incidents and the other people are usually only retaliating.

LINBURN has been diagnosed as a paranoid schizophrenic (I have contacted her doctor) and her life appears to go in cycles but is usually in some turmoil.

LINBURN is well known to local members, members at Control and Avondale. I do not know what can be done to stop her wasting our time and cannot help feeling that one day she is going to do something 'outrageous' and innocent people may well be victims. Her son Anthony does not appear very more rational than she.

I submit this file for DocLoc and your informaton. Perhaps Records Office staff can obtain all previous files on LINBURN and build a dossier, a copy of which could be kept at my office?

NOTE: also attached is a letter to note from Sgt JONES, Control.

MRS CAROLE LYMBURN

We act for Mrs Lymburn. We have been advised by her that she recently visited your supermarket to do some shopping. She asked the cashier for a receipt for the items she had purchased. We are instructed that there was some difficulty about providing her with a receipt. Mrs Lymburn says that, after she asked to see the Manager about the matter, you approached her in an unpleasant manner and said, in the presence of a considerable number of people, that she had been in Oakley Hospital. We are instructed that you also said to her "we are sick of you, we want to get rid of you". We are further instructed that you said to her "you are a bit funny in the head". Mrs Lymburn, who is an elderly woman, found these remarks extremely distressing. We have been advised by her that she has never been in Oakley Hospital. Consequently, any remark made in public to the effect that Mrs Lymburn has been in Oakley Hospital is defamatory. Mrs Lymburn has been advised that she has the right to bring a claim against you for damages for making those remarks about her in public.

Mrs Lymburn, however, will not pursue her legal rights if she receives from you a letter stating that the remarks made by you were untrue and totally without foundation. She also requires a written apology from you.

We would ask you to give this matter your urgent and serious attention. You will, or should appreciate the extreme concern, anxiety and distress experienced by our client.

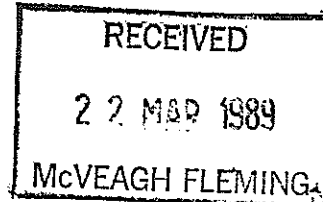

MRS CAROLE LYMBURN

In response to your letter dated 25 February 1990 I can see you are not fully aware of the facts or the sequence of events that occurred in our Supermarket.

Mrs Lymburn came through Terminal 7 manned by "Liz" an Island Cashier. When the total button was pressed, the receipt jammed and the Cashier was unable to give Mrs Lymburn a receipt. She then followed 3 Guys procedure by calling for a Supervisor to come and fix the jammed register. Jessica Henson a Maori Supervisor went to help and whilst trying to obtain Mrs Lymburns receipt was subjected to racist and uncalled for remarks. Jessica offered to scan the items again in order to give a receipt but the verbal flow continued until she had had enough and called the Manager. The verbal abuse consisted of remarks similar to:

You Maori and Islanders are all the same.  
Your staff are all gang members who are giving me trouble.  
You a gang member and you are hasselling me at home  
Why don't you move it along and hurry up.

Obviously there are witnesses to these remarks.

David Kerr, 3 Guys Manager then came to the front end and asked if he could be of assistance. Mrs Lymburn was immediately unreasonable and appeared to be in a highly excited state and continued to make insulting and racist remarks about Staff Members. These remarks were made in a very loud and rude manner. At no time did she appear co-herent.

Mr Kerr asked her to leave the Store but she refused, at which point he indicated he would call the police to have her removed. Mrs Lymburn reacted with much arm waving saying "call the Police, I'm not leaving", "Don't you touch me", "Get away from me you larrikin" etc. She then went over to the Pt Chevalier Citizens Advice to use their phone and did not return. Later Mr Kerr went over to Citizens Advice and was told by them that Mrs Lymburn had similar problems with other people.

Mr Kerr denies making the statements "we are sick of you", "we want to get rid of you", "you are a bit funny in the head". Mrs Lymburn at some stage said that she had a friend up at Oakley to which he replied "so you have been up there have you?"

3 Guys, Pt Chevalier have had one other incident with Mrs Lymburn when she accused a fellow elderly shopper of following her around the Store. This accusation was also untrue and false.

Once again I call on you for your advice and assistance in regard to my mother's neighbour problems at her residence at 82 Moa Rd Pt Chev. PH 862-517.

Last evening her neighbour Mrs Tan Kaka was entertaining friends and her recreational activities included bashing on the dividing wall of the two flats, yelling and calling out and behaviour which allowed my mother no considerations at all for rest and sleep.

At some point in the late evening my mother, in her dressing gown, went around to the front flat to request they quieten their noise.

Mrs Kaka's friend verbally attacked my mum with a vicious tongue, repeatedly screaming at her you C—T, you white maggot, and the part which causes me great concerns, threatened to beat her up.

THREATENING LANGUAGE

Sergeant in Charge

This report relates to a complaint by Carol LYMBURN of Threatening language by her neighbours living at 80 Moa Street GREY LYNN.

This matter has been an on-going one for the last 5 years and has been documented by previous units and the community policeman for Ponsonby who is aware of the situation.

The matter we attended today involved the neighbour and her friend telling LYMBURN that she was going to poke her eyes out and various other verbal abuse. The police were called by the complainant and when we attended the two persons making the abuse had left the area and did not return.

As a result the offenders were not spoken to. From talking to LYMBURN these threats are also made at various times by many other friends of the neighbours including death threats. LYMBURN's son was contacted and he has confirmed past incident's when he was present. He was not present at this morning's incident.
